Dear Resident(s),

We hope this letter finds you well. We wanted to share some important information with you regarding current and future air quality monitoring in the area. We understand the importance of keeping our community informed and want to ensure you have access to the latest updates.

We are pleased to let you know that the State of Colorado requires fenceline air quality monitoring at the Suncor Refinery. The Colorado Department of Public Health and Environment (CDPHE) has indicated that in the near future it expects the Integrated Public Alert and Warning System (IPAWS) to begin automatically notifying residents in affected communities around Suncor, when there is an emergency. IPAWS is the Federal Emergency Management Agency's (FEMA) emergency alert system, which does not require you to sign-up to receive notifications. This is the same system from which you already receive notifications on your mobile phone regarding extreme weather conditions (such as the warnings for flash floods, tornados, and blizzards), or public safety (such as Amber alerts). CDPHE has also introduced a non-emergency notification tool that enables residents to receive email and text notifications of Suncor-related activities in the Commerce City - North Denver area. You can sign-up for these notifications on CDPHE's website at https://cdphe.colorado.gov/ccnd-subscribe

CDPHE is responsible for a wide range of public health programs, including disease control and prevention, environmental health, emergency preparedness and response, health equity, and health promotion. They also monitor environmental health hazards, such as air and water quality, and develop policies and programs to protect the health of Colorado residents.
